Ms. Driscoll stated the houses that back up Longleaf on the corner of Orchid Way have no fence and there is no vegetation behind them. Is there anything we can do in that area?

Mr. Howell stated we have a buffer of trees, which are very sparse and there is a drain field beyond that.

Mr. Pollicino asked what can we plant as a visual barrier?

Mr. Howell responded probably a lot of spruce trees or cypress.

Mr. Pollicino stated if we are going to do it let's do it right and identify areas where it is visual and include that in the RFP.
